### 2015/31 Dyfed Powys Police

It has been a quiet month with no crime in the area. The police are trying to maintain a visible presence in Ystradfellte. There have been a lot of visitors to the area over Easter and there was one accident near Gwaun Hepste.

There has been double parking outside the White Horse but unless it is causing an obstruction there is nothing the police can do, if there is an issue call the police. Cllr Reynolds asked if there were any leaflets that could be handed out, they will ask Glynneath police if they have anything.

### 2015/32 County Borough Council

- a. There has been a meeting with Powys Highways regarding the car park in PNV, there have been 3 objections. Cllr. Thomas will request a meeting with Mr Horgan. Cllr. D Morgan of Glynneath said that N & PTT would probably look favourably on the car park development.
