### **2015/51 County Borough Council**

- a. Car Park PNV - Cllr. Thomas reported on the with meeting with Mr Horgan. He is still keen to proceed probably on October/November. He has had no response from N & PTTCBC. Cllr. D Morgan of Glynneath TC said that the flood plane had been updated by NRW and there was no risk. The TRO will not be submitted until the planning application has been submitted. Cllr. Thomas suggested having another meeting.
- b. There have been several complaints about the new recycling scheme in Ystradfellte but Powys CC will only pick up from designated points.
- c. Sat Navs problem in Ystradfellte - Powys CC were prepared to erect signs but Glynneath golf club are concerned that the lorries would have to turn in their drive. The signs should be erected on the PNV road on the N & PTCBC side.
- d. The Welsh Government are reviewing guidelines regarding Farm and Countryside Code of Practice.
- e. Cllr. Thomas read out the reply from John Forsey Powys CC regarding the recent consultation on public transport.
- f. Cllr. Thomas reported from a meeting with Powys Highways and said that there will be no road resurfacing only patching.
- g. The Ystradfellte road will be closed on Sunday 7th June for a bike ride, the car park in

Ystradfellte will also be closed. Cllr. Thomas will ask the organisers to inform S Wales Police.
