2015/79 County Borough Council

- a. Car Park PNV - see Dyfed Powys Police above.
- b. Powys CC must save 28 million and are setting a 3 year budget. This will have an impact on all communities. There is a proposal to remove revenue grant funding for village halls over 2 years.
