Minutes of the meeting of Ystradfellte Community Council held at Ystradfellte Church Hall on 6th October 2014 at 7.00 p.m.

### **2014/75 Minutes**

The minutes were passed as a true record proposed by Cllr. Jones and seconded by Cllr. Patrick

### **2014/76 Declaration of Interest**

### **2014/77 Dyfed Powys Police**

P.C.S.O. Templeman asked if there were any speeding issues in the area as they had received a complaint from Kirsty Williams A.M. There has been a speed problem on the road up to the village hall, Cllr. Thomas had a meeting with highways last week, there is a 30 m.p.h. sign there. There have been speed strips put down previously. The police do have a mobile hand held camera.

### **2014/78 County Borough Council**

- a. Ditch near Bryn Bwch - not done
- b. The road at Heol Calch from Ystradfellte to Coelbren is full of pot holes and the pipe under the road is still blocked - Mrs Powell has sent an email to Powys CC, Cllr. Thomas will check if John Powell has received it.
- c. Road sweeping and litter picking - Cllr. Thomas to investigate this.
- d. Speed wires near Aberllechau Farm Ystradfellte - the result of the speed wires was that the speed in that area was well under the limit. Working Farm signs are being erected there.
- e. Cllr. Thomas reported on the parking issues in PNV. A meeting is needed with Mr Horgan but Cllr. Thomas has been unable to contact him.
- f. The work to cut back trees in Coed y Rhaidr will be retendered as the first tender was too high. The work can be done now as the bird nesting season is over.

- g. Report of Summer Ambassadors by Cllr. Thomas. the council are moving the eligibility for adult social care, the consultation is on the Powys CC website.
- h. Cllr. Jones said that the telephone number on the Ystradgynlais website no longer works, Cllr. Thomas will investigate this. Cllr. Jones also reported that a resident who went to N & PTT minor injuries unit was advised to use Ystradgynlais but any hospital is available for emergencies.
