It was reported that Ystradfellte Reservoir had been broken into and £20,000.00 of equipment stolen.

2016/50 County Borough Council

- a. Car Park PNV – Cllr. Thomas had a meeting with Mr Horgan but BBNP had to cancel. Mr Horgan will not progress until N & PTCC submit the TRO. Cllr. Reynolds had been speaking to Mr Horgan's father who said that N & PTCC would support the application if he paid half of the TRO, Cllr. Thomas was not aware of this.
- b. Pot holes in Nedd valley - done.
- c. There is a lot of litter on the powder works track.
- d. PNV surgery - the builders are ready but there is a slight technically regarding a water pipe.

- e. Powys CC are reviewing refuse collections.
